## Coronavirus Disease 2019 (COVID-19) Outbreak, Update # 33 COVID-19 Vaccination Allocation Plan Update Quarantine Guidance Update

## Key Points and Recommendations:

- New Hampshire Division of Public Health Services (DPHS) has published an updated summary of the <u>COVID-19 Vaccination Allocation Plan</u>, which prioritizes vaccine for those at higher risk for severe COVID-19, or at risk for spreading COVID-19 to vulnerable populations, to reduce morbidity and mortality.
- COVID-19 vaccination is currently only available for Phase 1a persons.
  - All persons in Phase 1a are eligible for vaccination, including "moderate risk" health workers and first responders.
  - See prior NH DPHS <u>HAN #31</u> for information on how ambulatory health workers and first responders can access the COVID-19 vaccine.
- Vaccination for persons in Phase 1b is not yet open, but is expected to begin by the end of January. NH DPHS will provide instructions to the public on how to register for and access vaccination.
- NH DPHS quarantine guidance for people who are fully vaccinated or previously infected with SARS-CoV-2 has been updated (<u>Quarantine Guide</u>). This guidance applies to the general public, businesses, schools, and healthcare facilities, including long-term care facilities (LTCFs) and assisted living facilities (ALFs). The following people do NOT need to quarantine after an unprotected exposure to a person with COVID-19, or after travel outside of New England:
  - A person who is 14 days beyond the second dose of their COVID-19 vaccine (i.e., 14 days after full vaccination).
  - A person who is within 90 days of a prior SARS-CoV-2 infection diagnosed by PCR or antigen testing.
    - People with prior infection should be vaccinated to provide the highest level of protection against COVID-19.
- Staff and residents of LTCFs/ALFs who are at least 14 days beyond their second dose of a COVID-19 vaccine, or who are within 90 days of a previous SARS-CoV-2 infection (diagnosed by PCR or antigen testing), may be exempted from the COVID-19 Resident and Staff Surveillance Program (CRSSSP) unless otherwise required to test under CMS requirements.
- Regardless of prior infection or vaccination status, any person with new or unexplained <u>symptoms of</u> <u>COVID-19</u> still needs to isolate (<u>Isolation Guide</u>), and be evaluated for COVID-19 testing.
- NH DPHS and CDC continue to discourage any non-essential travel, even for people fully vaccinated or previously infected because protection is not 100%, durability of immunity is still unknown, and there are new circulating strains of SARS-CoV-2 in other states and countries that are being investigated.

 It remains possible that people who are fully vaccinated or previously infected could still acquire asymptomatic SARS-CoV-2 infection, or attenuated (milder) COVID-19. Therefore, even people who are fully vaccinated or previously infected need to continue to practice physical distancing, avoid social groups and gatherings, and wear face masks at all times when in public places and facilities. Healthcare providers should continue to follow all recommended infection control and personal protective equipment (PPE) guidance.
